TGP regards the continual improvement of environmental impact of the company's activities as an essential business objective.

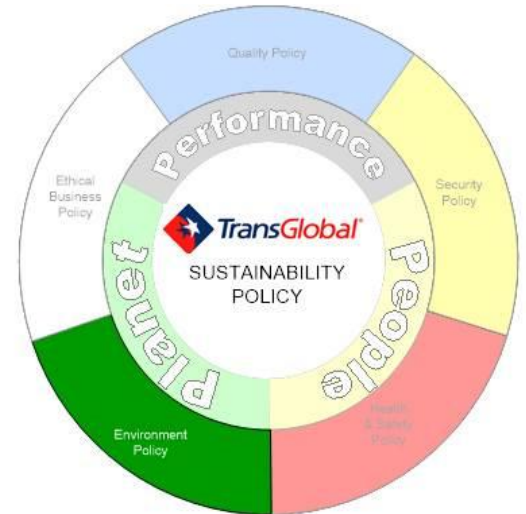
TGP has committed to:

- Put in place sufficient pollution prevention or containment plans and controls, appropriate to the risk of the substances being used or transported and the environment and ecosystem in question,
- Manage the disposal of waste, particularly hazardous waste, to minimise environmental harm and maximise recoverable scarce resources,
- Utilise the environmental impact of competing solutions as a criteria in procuring services or when assisting TGP customers in selecting solutions,
- Encourage TGP's suppliers to work towards the standards that it aspires to and reward those who share this vision,
- Advise and support TGP customers and suppliers to understand their environmental impact and work towards the objectives above,
- Communicate this policy and the progress in achieving its objectives openly and enthusiastically with partners, communities and the wider public,
- Comply with the provision and spirit of environmental legislation applicable to TGP activities. TGP aims to apply the highest applicable standards in all territories, irrespective of the reach of legislation and will never use disparity of legislation to relocate poor practice.

In pursuit of these commitments, TGP has integrated the management of environmental performance, including occurrence reporting, audit and review, into its Integrated Management System. This system is certified to the ISO 14001 Environmental Management System standard. The suitability of this policy and the achievement of its objectives are regularly reviewed by the company.
